<p><b>3.</b> I will request a 2015 Tax Return Transcript from the IRS (visit <a href="http://www.irs.gov">www.irs.gov</a> or call 1-800-908-9946 to request your transcript). <p><b>4.</b> I filed a tax extension for the 2015 tax year. Attached is a copy of my IRS Form 4868. Also attached are all copies of my 2015 W2s and a signed, written statement estimating my 2015 Adjusted Gross Income and 2015 taxes. I understand the attached documents will be used to preliminarily complete the verification process.
